Sabadell Horizonte 10 2025, Fl is an investment fund with a non-guaranteed objective of recovering 100% of your initial investment plus a return profitability of 2.50% APR on 31 October 2025.

# How will I obtain the non-guaranteed return profitability of the Fund?

- On 31 October 2024, you will receive the lump sum in respect of a mandatory redemption of 2.50% on your initial investment, once it has been adjusted for possible redemptions or voluntary transfers you may have made.
- On 31 October 2025, the non-guaranteed target is to recover 100% of the initial investment (valued on 13 October 2023) plus an additional revaluation to obtain the 2.50% APR.

It is important that you be aware that the estimated non-guaranteed profitability of the return is for units subscribed until 13 October 2023 and that are maintained until 31 October 2025, adjusted for possible redemptions and/or voluntary transfers. THE ESTIMATED PROFITABILITY OF THE RETURN IS NOT GUARANTEED, the one finally achieved by the Fund could differ as a result of changes that may occur in the assets held in the portfolio or the market evolution of interest rates and the credit of the issuers.

#### What assets does this Fund invest in?

Sabadell Horizonte 10 2025, Fl will invest:

At least 75% of its assets in public debt, issued or guaranteed by EU States, by autonomous communities, by local entities and by international/supranational organisations of which Spain is a member.

The rest will be invested in private fixed income, money market instruments, deposits, up to 10% in other Collective Investment Institutions (CIIs) and in liquidity.



### All the tax advantages offered by investment funds

- If you invest in Sabadell Horizonte 10 2025, you will benefit from the tax advantages of investment funds if you are an individual natural person resident in Spain.
- In accordance with current tax law, investment funds are not taxed until they are disinvested, so if you are a natural person resident in Spain and you transfer the accumulated capital to another investment fund, you will not have to pay tax.
