

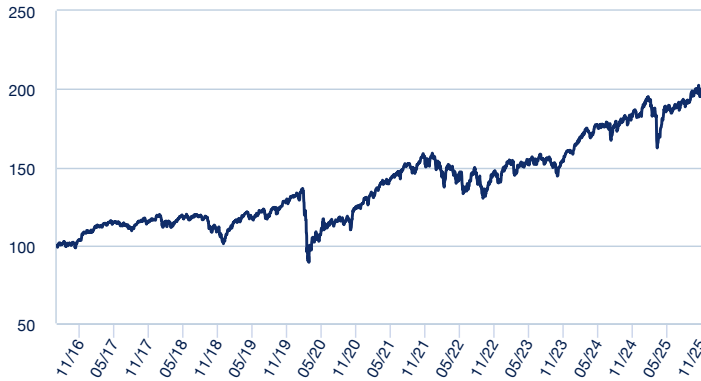
**INVESTMENT POLICY**

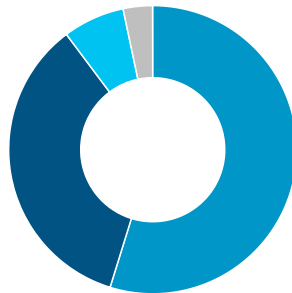
