

INVESTMENT POLICY

Sabadell Prudente, FI invests mainly in other CIIs. The equity position is between 0% and 30% with no capitalisation limit. The selected equity CIIs invest in Western Europe and in other markets such as the United States, Japan or emerging countries. It also invests in global equity CIIs specialised in specific economic themes or sectors and up to 15% in CIIs investing in commodities. The selected fixed income CIIs invest in public and private fixed income instruments denominated in any currency. It may invest in CIIs specialised in corporate and high yield bonds. The portion not invested in Funds is invested in public and private fixed income assets, without geographical or currency restriction, and in non-traded deposits and money market instruments. The selection is made taking into account not only economic and financial aspects but also extra-financial criteria of sustainable investment, environmental, social and governance, also known as ESG, by applying the ESG methodology developed by Amundi. 






Fixed Income asset class

Alternatives allocation





ESG Terminology

ESG criteria

The criteria are extra-financial criteria used to assess the Environmental, Social and Governance practices of companies, states or local authorities:

- "E" for Environment (energy and gas consumption levels, water and waste management, etc.).
- "S" for Social/Society (respect for human rights, health and safety in the workplace, etc.).
- "G" for Governance (independence of board of directors, respect for shareholders' rights, etc.)

ESG Rating

The issuer's ESG rating: each issuer is assessed on the basis of ESG criteria and obtains a quantitative score, the scale of which is based on the sector average. The score is translated into a rating on a scale from A (highest rating) to G (lowest rating). The Amundi methodology provides for a comprehensive, standardised and systematic analysis of issuers across all investment regions and asset classes (equities, bonds, etc.)

ESG rating of the investment universe and the portfolio; the portfolio and the investment universe are given an ESG score and an ESG rating (from A to G). The ESG score corresponds to the weighted average of the issuers' scores, calculated according to their relative weighting in the investment universe or in the portfolio, excluding liquid assets and non-rated issuers

Amundi ESG Mainstreaming

In addition to complying with Amundi Responsible Investment Policy⁴, Amundi ESG Mainstreaming portfolios have an ESG performance objective that aims to achieve a portfolio ESG score above the ESG score of their ESG Investment universe.
