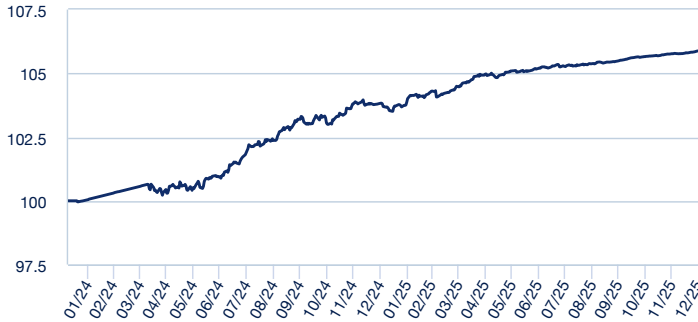


INVESTMENT POLICY

It is a Fund with the non-guaranteed objective of recovering 100% of the initial investment plus a return of 2.50% APR UNGUARANTEED on 3 November 2026. On 3 November 2025, a fixed amount, corresponding to a mandatory redemption, of 2.13% of the initial investment will be received, adjusted for any redemptions and/or voluntary transfers made. It invests at least 60% of its assets in debt issued or guaranteed by EU Member States, by Autonomous Communities, by Local Entities and by International/Supranational Organisations of which Spain is a member. The remainder is invested in private fixed income, money market instruments, deposits, up to 10% in other CII and liquidity. At the date of purchase, the issues will have at least investment grade (minimum rating BBB- or equivalent). A fuller description of the investment policy can be found in the key information document (PRIIPs KID) available at sabadellassetmanagement.com.

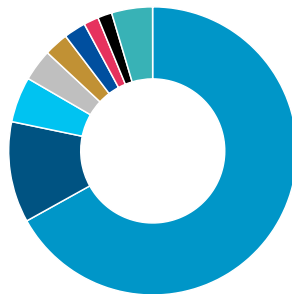

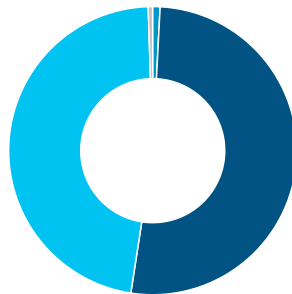
Sectorial distribution
