

**INVESTMENT POLICY**

The Fund aims at building a diversified portfolio adapted to the expectations of its Management Company, on the various financial assets at any given time, and may adopt a very conservative strategy if the market context is considered unfavorable. The investments will be located both in markets of member states of the OECD and in emerging countries without any geographic restriction nor established limit. There is no defined limit of exposure to currency risk. The distribution of the investment between the fixed income and equities markets will not be predetermined in line with the evolution expected with regard to each one. No minimum credit rating is required for fixed-income investments. There is no maximum or minimum capitalisation limit when selecting securities. 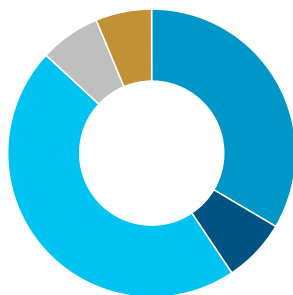

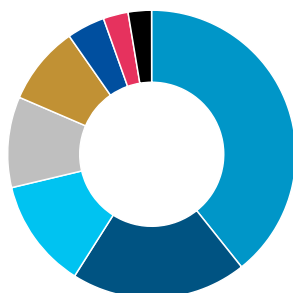

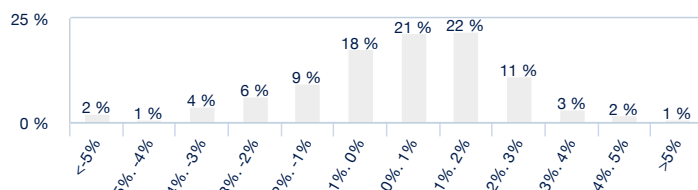
