

INVESTMENT POLICY

The Fund invests at least 70% of its total exposure in public and private fixed income, mainly with a maturity equal to or less than the time horizon, money market instruments, deposits, other UCIs including those managed by this Management Company (maximum 10%) and, to a lesser extent, in liquidity. At least 60% of this exposure will have a minimum credit rating of BBB-, or equivalent, at the time of purchase. A small portion of the portfolio, normally around 0.70% (maximum 1%) of its assets, is allocated to the purchase of options on European stock indices, with the aim of obtaining a possible additional revaluation, without the total exposure to equities exceeding 30%. The Fund's time horizon is 31 January 2030. A fuller description of the investment policy can be found in the Key Investor Information document (PRIIPs KID) available at sabadellassetmanagement.com. **WARNINGS:** This Fund may invest up to 40% in fixed income issues of low credit ratings and therefore has a high credit risk. 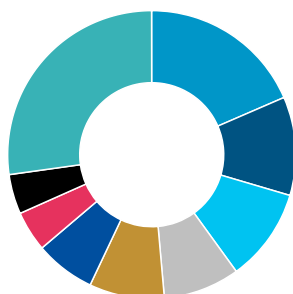

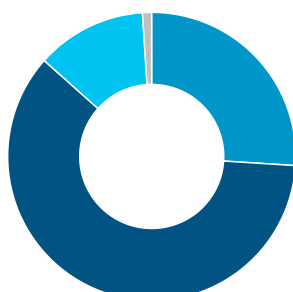
