

Asset Management INVESTMENT POLICY

The Fund invests primarily in shares of companies headquartered, or carrying out the majority of their activities, in Europe. It selects companies that have adopted or will adopt a path of positive environmental, social and good governance (ESG) practices, focusing on those that aim to improve their ESG criteria in the future and those that are currently ESG leaders in their sectors. The selection of securities takes into account not only economic and financial aspects but also extra-financial criteria of sustainable investment, environmental, applying the ESG methodology developed by Amundi

Further description of the investment policy can be found in the key investor information document (KIID), which is available at sabadellassetmanagement.com. WARNING: This Fund can invest up to 25% in fixed income securities rated below investment grade, which represents a high credit risk.



The Fund is actively managed against a benchmark and seeks to outperform the MSCI Europe Net Total Return Index. The Fund is primarily exposed to benchmark issuers. However, management of the Fund is discretionary and will be in issuers not included in the benchmark. The Fund monitors risk exposure relative to the benchmark, even if EMPRESA unit class is intended exclusively for legal entities. the deviation from the benchmark is significant.







ESG Terminology

ESG criteria

The criteria are extra-financial criteria used to assess the Environmental, Social and Governance practices of companies, states or local authorities:

"E" for Environment (energy and gas consumption levels, water and waste management, etc.).

"S" for Social/Society (respect for human rights, health and safety in the workplace, etc.).

"G" for Governance (independence of board of directors, respect for shareholders' rights, etc.)

ESG Rating

The issuer's ESG rating: each issuer is assessed on the basis of ESG criteria and obtains a quantitative score, the scale of which is based on the sector average. The score is translated into a rating on a scale from A (highest rating) to G (lowest rating). The Amundi methodology provides for a comprehensive, standardised and systematic analysis of issuers across all investment regions and asset classes (equities, bonds, etc.) ESG rating of the investment universe and the portfolio: the portfolio and the investment universe are given an ESG score and an ESG rating (from A to G). The ESG score corresponds to the weighted average of the issuers' scores, calculated according to their relative weighting in the investment universe or in the portfolio, excluding liquid assets and non-rated issuers

Amundi ESG Mainstreaming

In addition to complying with Amundi Responsible Investment Policy⁴, Amundi ESG Mainstreaming portfolios have an ESG performance objective that aims to achieve a portfolio ESG score above the ESG score of their ESG Investment universe.
